Vehicle access to grass areas may be granted but must be limited as much as possible.

Security and traffic control during the event are the responsibility of the permittee.

### How do I schedule a special event?

Your application will be reviewed by the park staff and may require a review by the Harrison County Park Board if it is of a large scale.

If your Special Event Permit application is approved, you may be required to meet with the park staff to review special needs.
